

Mrs. Miller moved to add emergency language to resolution 2014-15. The motion was seconded by Mrs. Carter. The motion passed unanimously.


Mrs. Rhoads moved to adopt resolution 2014-15. The motion was seconded by Mr. Barrington. The motion passed unanimously.
