**Finance Committee Minutes**

Mr. Stallard called the meeting to order at 7:28 PM.

Present: Rick Stallard (Acting Chairman), Kathy Rhoads, Brad Demiter, Gene Sulzener

Absent: Leslie Miller, Sue Frey

Mr. Sulzener moved to approve the minutes from 9-05-2017. The motion was seconded by Mr. Stallard. The motion passed unanimously with the exception of Mr. Demiter who abstained.

Amendments to the agenda:

Mrs. Rhoads moved to add a vote on the unemployment benefits for former police officer Earl Fockler. The motion was seconded by Mr. Stallard. The motion passed unanimously. The item will be added to new business.

Privilege of the floor:

The Fiscal Officer presented the August financial statements. There were no issues at this time. It was noted that there are no free sidewalks provided to Village residents.

The first draft of the 2018 budget was presented to the committee. Mrs. Rhoads said that she would like to see \$30,000 put back into the Bike Trail Fund. She also asked that more money be put into the Road Improvement Fund to cover the loan shared with BOPA for the Water Line Project. The budget as it currently stands includes money for a seventh police officer and an upgraded pay scale for the police department. There was a discussion of the increases in appropriations that caused the current budget to show a negative balance in the 2018 ending General Fund balance. Several appropriations with large increases were discussed. Committees will have to reassess appropriation requests for the Council imposed \$500,000 minimum in the General Fund and the end of 2018 to be achieved.
