Old business:

The payroll audit is nearly complete. The final report should be given to the Solicitor for review prior to its disbursement to Council. The Solicitor will be contacted to determine if the review of the report should be done at an open meeting or at an executive session of Council.

There was a discussion on level raises in the 2013 budget. A moratorium on level raises may be required. The Solicitor will be contacted to determine the necessary legislation to put a moratorium on level raises in 2013.

The paperwork for level raises should be presented to Council prior to the raise taking effect. The requested paperwork for the increase for Officer Scott Phillips has not been received yet.

Mr. Stallard made a motion to adjourn. The motion was seconded by Mrs. Rhoads. The motion passed unanimously. The meeting adjourned at 9:42 PM.
