



**Seville Street Committee
November 28, 2012**

Chairman Roger Kilgore called the meeting to order at 7:33 p.m.

Roll Call:

Chair Roger Kilgore, Kathy Rhoads, and Alternate Leslie Miller.

Absent: Larry Landis

Kathy Rhoads made a motion to approve the Street Committee Minutes of October 24, 2012, and Roger Kilgore seconded the motion. Two Aye votes and Leslie Miller abstained. The minutes were approved as written.

Streets & Parks Commissioner's Report:

The attached report was submitted by Jon Sobczak.

Privilege of the Floor:

Leslie Miller had spoken with Chris Jacob. Mr. Jacob has received the contract for the Block Grant. Mr. Jacob said they will take care of the work involved due to it being awarded and paid for by the County. Mrs. Miller asked Mr. Sobczak for a list of the top 33 ADA ramps and to include the walkways into the park.

Kathy Rhoads asked for information to put on the website for the Block Grant. Mrs. Miller will try and have something after the first of the new year.

New Business:

Kathy Rhoads suggested a possible subcommittee to handle donations from businesses and residents for Christmas decorations. Simple decorations cost as much as \$500 for one lamp post snowflake. The Committee will keep their eyes open for anyone interested.

Old Business:

Chair Kilgore asked about the sidewalk repair list. Mr. Sobczak said there are approximately 88 sidewalks that need to be repaired or installed. It was discussed how to prioritize the list and how to control the cost of The Village doing the repairs.

The Liberty Street Bridge analysis inspection should start on December 10th and The Village should receive the report by late January 2013.

El Patron restaurant has agreed to do their part for the sidewalk installation. Mr. Sobczak is waiting for Dollar General's corporate response.


