Mayor Sulzener called the meeting to order at 7:05 PM.

The meeting began with the Pledge of Allegiance.

Mrs. Miller moved to approve the bills from 02-10, 02-18, 02-24, and 03-03. The motion was seconded by Mr. Barrington. The motion passed unanimously.

Mrs. Carter moved to approve the minutes from 02-10. The motion was seconded by Mr. Barrington. The motion passed unanimously.

The Guilford Township Trustees nominated Cheryl Bock as a trustee of The Mound Hill Cemetery Board of Trustees. The nomination was seconded and unanimously passed. The cemetery will continue to operate in the same way it always has with the exception that the governing board of trustees will only be meeting once or twice per year instead of the current monthly meeting. The day to day operations will be conducted by the Guilford Township trustees. The Solicitors from Guilford and Seville will prepare legislation for the change.

Privilege of the floor:

Resident Jeremy Gundelson asked about installing a fiber optic line for residents internet use. It was explained that there is a high speed fiber optic line in Seville but it was currently only available to commercial customers. Bringing another cable company into Seville could lower rates. A possible joint venture with surrounding communities could also get better internet rates for everyone.

Solicitor's Report-Ted Lesiak:

Mr. Lesiak said he could draft a drug free work place policy. He can also begin work on an updated pay ordinance and an update of the rules of council. A village policy update is also due. Mrs. Miller moved to give permission to Mr. Lesiak to work on the above noted projects. The motion was seconded by Mr. Landis. The motion passed unanimously.


Mrs. Rhoads asked that the Council members provide input as to which proposed header for the web-site they would prefer.


