Mayor Carter suggested that since the rent is so low and has been the same for a while, we should look at increasing the rent starting next year to help cover the cost of repairs as the building ages. This will be addressed through Government Committee.

Mr. Manges discussed some issues with sidewalks in the village. He would like to look into community block grants to help cover the cost of some of these repairs.

- **Re-Surfacing of Municipal Building parking lot:** We are still waiting to hear when this will be done.


Privilege of the floor:
