PRIVILEGE OF THE FLOOR: Joe Crych of Autumn Meadows came to speak about the Geese issue in the development. There are a lot of complaints from homeowners. He has spoke with the ODNR and he is aware they are protected but they gave him suggestions of some ideas that might help. He is currently using a green laser light and he is aware they cannot be pointed at the road or up in the sky. Sergeant Banks commented he talked to the local game warden who did give some suggestions of things they can do to harass the geese so they don't want to be there. Sergeant Banks also stated we do not have any criminal law for feeding the geese. We currently do not have an ordinance for this. Mr. Crych commented he would like to see if the Village would consider having an ordinance about feeding the geese. He commented both Wadsworth and Medina have such ordinances. The Committee agreed we discuss the issue with our Solicitor and Government Committee.
