Parks & Streets Superintendent's Report: See the Parks & Streets Superintendent's report attached. The speed bump has been added to Cy Hewit Park to slow drivers down.

New Business:

• Field Usage Form – Mrs. Gray talked with Mr. Manges about coming up with a field usage form. She passed out a draft and asked the committee members to look it over and make any suggestions for change. The plan is to invite all of the sports leagues to the meeting in November to go over the new form and expectations for the upcoming year.

Mr. Manges did mention that the football administrator is wanting to take down the old building they use for a concession stand at Memorial Field and put up a new one. They do have some funds set aside but was hoping we could also look for a grant. These buildings belong to the Village as they are located on and insured by our liability policy. As a result, the Village should obtain keys for all of the buildings.

- Park Avenue Mr. Eby noticed the business advertising sign located at the end of Park
 Avenue is looking warn out and needs some repairs. We will work with Zoning about
 contacting whoever is in charge of the sign and ask them to make the needed repairs.
 There also some high weeds on the north side of the road that can be taken care of as
 well.
- Movie Night Mr. Eby thought it would be nice for us to plan for a movie night at the park for next summer. The committee agreed and we would like to plan for next year at one of the parks and get some residents involved.
- **Supernatural Trick O'Treat Event** Mayor Carter submitted the event form for the Supernatural Trick O'Treat event downtown. The committee approved the event.

Old Business:

- Halloween Revised After discussion in other committees the committee decided to continue to support Trick O'Treat in the Village on Halloween, October 31^s from 6:00PM 8:00PM
- Playground Update: Mr. Manges had a meeting last week and the equipment will be delivered tomorrow and should be installed the last week of this month.
- Passive Park Discussion Mrs. Gordon passed out a definition of a Passive Park. The committee agreed the exercise station would not be a great plan for the park and is costly. The committee would however, like to be able to have electric in the Pavilion for renters. The committee agreed this would be fine. The deed for Leohr Park does not currently define it as "passive", however, the planning committee remembers it being designated to be a Passive Park. The committee would like to continue to discuss how they want to reflect this in writing for the future. Mrs. Gordon suggested that the zoning approval process add park planning verbiage for any future developments. She felt this was a topic during the Comprehensive planning discussions. The committee will continue discussion at next meeting.
