PRIVILEGE OF THE FLOOR: John & Lisa Nemastil of 116 W Greenwich came to speak regarding the current changes to the zoning code 808 with regard to recreational vehicle yard restrictions. This is Ordinance 2025-57.

Mr. Nemastil stated he feels this is a rule a HOA would have, not a village. They have a trailer and it has current plates. They make sure it is kept clean and locked up on their front drive on concrete. He uses his trailer during the months the new code says it should be parked in the back or side yard or stored somewhere else. Mrs. Nemastil stated due to the zoning code, they are unable to park in back or side yard due to space that is required. Mr. Nemastil stated he does not want to store his trailer somewhere else, he wants to have it at his home so he can keep an eye on it and take care of it. Mrs. Nemastil stated she has done some research and noticed there are several trailers and campers and some are parked on the side yard but the restrictions are only for the front yard. Many of them have grass growing up around them. After doing more research she noticed this new change seems similar to what Medina has in their code. She stated Seville is not the city of Medina. It has a different demographic and she does not want to live in Medina. Mayor Carter agreed we need to take a closer look at the code. She stated we will take it back to Zoning to review again and invited the Nemastils to attend and speak at a Zoning meeting as well.
